We, the undersigned, do hereby petition for the annexation of the area of land, the legal description of which is described in the attached "Exhibit A" which is contiguous to the City of Ferndale, a non-charter code city of the State of Washington, and which is within the City's Short Term Planning Area as identified in the Whatcom County Comprehensive Plan. We, the undersigned, are the owners of not less than 60-percent of the land in value, based on assessed valuation for general taxation of the property for which the annexation is petitioned. A map "Exhibit B" which outlines the boundaries of the property sought to be annexed, accompanies the petition.

Upon annexation of the area that is the subject of this annexation petition, the area will assume it's fair share of the City's indebtedness.
